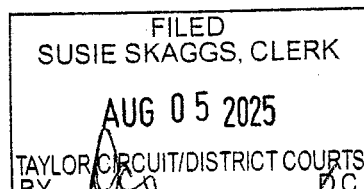

The Grand Jury charges that on or about May 13, 2025, in Taylor County, Kentucky, the above-named defendant knowingly and unlawfully possessed a controlled substance that is classified as a Schedule I or II, which is a narcotic drug; a controlled substance analogue; Methamphetamine; lysergic acid diethylamide; phencyclidine; gamma hydroxybutyric acid (GHB), including its salts, isomers, salts of isomers, and analogues; or flunitrazepam, including its salts, isomers and salts of isomers, or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 2:

The Grand Jury charges: That on or about May 13, 2025, in Taylor County, Kentucky, the above-named defendant having no right to do so or any reasonable ground to believe that he or she has such right, he or she: intentionally or wantonly defaces, destroys, or damages any property causing pecuniary loss of less than five hundred dollars (\$500); or As a tenant, intentionally or wantonly defaces, destroys, or damages residential rental property causing



pecuniary loss of less than five hundred dollars (\$500) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 3:

Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 2:

The Grand Jury charges that on or about June 18, 2025, in Taylor County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 4:

The Grand Jury charges that on or about June 18, 2025, in Taylor County, Kentucky, the above-named defendant failed to register transfer of vehicle with the county clerk in said county or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 5:

The Grand Jury charges that on or about June 18, 2025, in Taylor County, Kentucky, the above-named defendant who has not applied for an operator's license or whose operator's license has been denied, canceled, suspended, or revoked, or whose privilege to operate a motor

vehicle upon the highways while the license is denied, canceled, suspended, or revoked or his privilege to operate a motor vehicle is withdrawn, or the license has not been applied for or aided, abetted or counseled with another in said act. COUNT 1:

The Grand Jury charges: That on or about May 15, 2025, in Taylor County, Kentucky, the above-named defendant intentionally caused serious physical injury to another person; or he intentionally causes physical injury to another person by means of a deadly weapon or a dangerous instrument; or wantonly causes serious physical injury to another person by means of a deadly weapon or a dangerous instrument or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 2:

The Grand Jury charges: That on or about May 15, 2025, in Taylor County, Kentucky, the above-named defendant a person is guilty of terroristic threatening in the second degree when, other than as provided in KRS 508.075, he or she intentionally: (a) With respect to any scheduled, publicly advertised event open to the public, any place of worship, any school function, any workplace, or any gathering of three (3) or more persons, threatens to commit by any means, including by use of a firearm, any act likely to result in death or serious physical injury to any person. A threat directed at a person or persons at a scheduled, publicly advertised event open to the public, place of worship, school, workplace, or gathering of three (3) or more persons does not need to identify a specific person or persons or school in order for a violation of this section to occur; (b) Makes false statements by any means, including by electronic communication, indicating that an act likely to result in death or serious physical injury is occurring or will occur for the purpose of: 1. Causing evacuation of a school building, school property, or school sanctioned activity; 2. Causing cancellation of school classes or school-sanctioned activity; or 3. Creating fear of death or serious physical injury among students, parents, or school personnel; (c) Makes false statements that he or she has placed a weapon of mass destruction at any location other than one specified in KRS 508.075; or (d) Without lawful authority places a counterfeit weapon of mass destruction at any location other than one specified in KRS 508.075 or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 3:

The Grand Jury charges: That on or about May 15, 2025, in Taylor County, Kentucky, the above-named defendant intentionally prevents or attempts to prevent a peace officer, recognized to be acting under color of his official authority from effecting an arrest of the actor or another by: using or threatening to use physical force or violence against the peace officer or another; or using any other means creating a substantial risk of causing physical injury to the peace officer or another or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 4:

The Grand Jury charges that on or about May 15, 2025, in Taylor County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of

the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 5:

The Grand Jury charges: That on or about May 15, 2025, in Taylor County, Kentucky, the above-named defendant when he or she: in a public place and with intent to cause public inconvenience, annoyance, or alarm, or wantonly creating a risk thereof: engages in fighting or in violent, tumultuous, or threatening behavior; make unreasonable noise; or refuses to obey an official order to disperse issued to maintain public safety in dangerous proximity to a fire, hazard, or other emergency; or creates a hazardous or physically offensive condition by any act that serves no legitimate purpose or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 6:

The Grand Jury charges: That on or about May 15, 2025, in Taylor County, Kentucky, the above-named defendant intentionally placed another person in reasonable apprehension of imminent physical injury or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 7:

The Grand Jury charges: That on or about May 15, 2025, in Taylor County, Kentucky, the above-named defendant is guilty of obstructing a highway or other public passage when having no legal privilege to do so he, alone or with other persons, intentionally or wantonly renders any highway or public passage impassable without unreasonable inconvenience or hazard or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

COUNT 8:

The Grand Jury charges that on or about May 15, 2025, in Taylor County, Kentucky, the above-named defendant was operating a motor vehicle with expired operator's license or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.


