The Grand Jury charges that on or about December 17, 2023, in Taylor County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 3:**

The Grand Jury charges: That on or about December 17, 2023, in Taylor County, Kentucky the above-named defendant having no right to do so or any reasonable ground to believe that he has such right, he intentionally or wantonly defaces, destroys or damages any property causing pecuniary loss of \$1,000 or more or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 4:**

COUNT 9

COUNT 13

KRS: 189.110 – Obstructed Vision and/or Windshield (Violation) (UOR 00231)

**COUNT 1:**

The Grand Jury charges that on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant knowingly and unlawfully possessed a controlled substance that is classified as a Schedule I or II, which is a narcotic drug; a controlled substance analogue; **Methamphetamine**; lysergic acid diethylamide; phencyclidine; gamma hydroxybutyric acid (GHB), including its salts, isomers, salts of isomers, and analogues; or flunitrazepam, including its salts, isomers and salts of isomers, or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 2:**

The Grand Jury charges: that on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant believing that an official proceeding is pending or may be instituted, he/she: destroys, mutilates, conceals, removes or alters physical evidence which he/she believes is about to be produced or used in the official proceeding with intent to impair its verity or availability in the official proceeding; or fabricates any physical evidence with intent that it be introduced in the official proceeding or offers any physical evidence, knowing it to be fabricated or altered or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 3:**

The Grand Jury charges: That on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant knowingly introduced dangerous contraband into a detention facility, or a penitentiary OR being confined in a detention facility, or a penitentiary knowingly made, obtained, or possessed dangerous contraband or aided, abetted, or counseled with another in commission of said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 4:**

The Grand Jury charges that on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug paraphernalia

or aided, abetted or counseled with another in said act. Said act against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 5:**

The Grand Jury charges that on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant knowingly and unlawfully possess a controlled substance classified in Schedules IV or V or aided, abetted or counseled with another in said act. Said act against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 6:**

The Grand Jury charges that on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant was operating a motor vehicle anywhere in this state: having an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the influence of alcohol; while under the influence of any other substance or combination of substances which impairs one's driving ability; while the presence of a controlled substance listed in subsection (12) of this section is detected in the blood, as measured by a scientifically reliable test, or tests, taken within two (2) hours of cessation of operation or physical control of a motor vehicle; while under the combined influence of alcohol and any other substance which impairs one's driving ability; or having an alcohol concentration of 0.02 or more as measured by a scientifically reliable test or tests of a sample of the person's breath or blood taken within two (2) hours of cessation of operation or physical control of a motor vehicle, if the person is under the age of twenty-one (21) or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 7:**

The Grand Jury charges that on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant failed to maintain required insurance/security or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 8:**

The Grand Jury charges: That on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant knowingly and unlawfully possesses marijuana or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 9:**

The Grand Jury charges that on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant failed to have registration plate conspicuously upon the rear of the motor vehicle or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 10:**

The Grand Jury charges that on or about November 16, 2023, in Taylor County,

Kentucky, the above-named defendant failed to have the receipt issued by the cabinet through the county clerk constantly in his possession or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 11:**

The Grand Jury charges: That on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant improperly displayed the registration plate or aided, abetted, or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 12:**

The Grand Jury charges: That on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant failed to produce written proof in the form of an insurance card that the insured has in effect an insurance contract providing security in conformity with this subtitle or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

**COUNT 13:**


The Grand Jury charges: That on or about November 16, 2023, in Taylor County, Kentucky, the above-named defendant shall not operate a motor vehicle on a public highway, road, or street with any sign, sunscreening material, product, or covering attached to, or located in or upon the windshield, except the following: a certificate or other paper required to be displayed by law; sunscreening material along a strip at the top of the windshield, if the material is transparent and does not encroach upon the driver's direct forward viewing area as defined in Federal Motor Vehicle Safety Standards No. 205 as the AS/1 portion of the windshield or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.
